National Identification Cards

What type of document can youth seek which will allow them to move around the country?

If you are a youth who was born in Bolivia, then having an original birth certificate is very important. It is the main document that you will need in order to get a National ID Card.

The other document that youth should seek, if possible, is a National ID Card. For youth under 18 years old, these are the documents that are required in order to get a National ID Card:

- Original birth certificate issued from 2007 onwards (Only for First Time registration in the RUI-SEGIP system)
- Bank deposit slip.
- Physical presence of the minor.
- Physical presence of one or two parents carrying their valid identity cards and a photocopy of them, also in renewal and replacement.

What documents do I have to have to get a National ID? Is there any document that I must have to get an ID?

What if my documents do not have my correct name/address?

A correction in the ID data may be requested to SEGIP provided that the error can be proved. However, Law 145 of June 27, 2011 and the internal SEGIP regulation (*Reglamento Registro Unico Identificacion Personal*) do not say anything about a specific procedure.

What if I only have foreign documents?

If you have foreign documents, you can obtain a Foreigner Identity Card, it is issued by SEGIP. But first, you must get a temporary or permanent residence sticker from the General Directorate of Migration.

Here are the steps to obtain a Foreigner Identity Card:

- 1. Get a temporary or permanent residence sticker from the General Directorate of Migration
 - (a) To get this, you will need a foreign identification document, like a Passport or National Identification Document
 - (b) General Directorate of Migration website has a form to apply for temporary or permanent residence: <u>http://www.migracion.gob.bo/node/130</u>
- 2. Pre-register on the SEGIP website by filling out an online form
 - (a) On SEGIP website, select "Foreigners>Foreigner Identity Card>Pre-Registration", and click on the "PRE-REGISTRATION" link
 - (b) Form will require you to enter the passport number or National Identification Document number that you used when getting your residence sticker (in step 1 above)
 - (c) Form will require you to provide the residence sticker documentation that you were given by the General Directorate of Migration (in step 1 above)
 - (d) A fee is required to complete pre-registration
- 3. Once pre-registration is complete, you must make an appointment online with SEGIP to visit one of their offices to complete the process. Here is a list of things you must bring with you to the SEGIP office:
 - (a) Passport or National Identification Document that you used when getting your residence sticker (in step 1 above), bring the original and a photocopy
 - (b) Permanence granted by the General Directorate of Migration (in step 1 above), bring the original and a photocopy
 - (c) Delivery certificate or notification seal (as appropriate) that was provided by the General Directorate of Migration (in step 1 above), bring the original and a photocopy
 - (d) Administrative resolution granting permanence by the original General Directorate of Migration (in step 1 above)

- (e) Pre-registration form printed and signed by you
- (f) Receipt for the payment of the fee in your name, bring the original and a photocopy (the fee is paid online during pre-registration)

What happens if my documents are not accepted to get a National ID card?

Law nº 145 dated June 27, 2011 does not say anything about it.

Internal regulation of SEGIP in article 10 states that the following may be valid documents to obtain, renew or modify the data in the RUI system:

- Birth certificate
- Marriage certificate
- Death certificate.
- SERECI certifications.
- SERECI Administrative Resolutions.
- Judicial Resolutions.
- Certifications issued by Consulates, with the verification and support of the SIRENA System
- Others that SEGIP defines through Instructions.

Do I have to be a resident of the country to get a National ID card?

Yes; you must be of Bolivian nationality to get a National ID card. As long as you are of Bolivian nationality, you can get a National ID card whether you reside in Bolivia or abroad.

If you are not of Bolivian nationality, then you can get a Foreigner Identity Card instead of a National ID Card.

What does it mean to be a resident of this country? How do I prove residency?

Being a resident of Bolivia can mean a few different things, and it depends on where you were born.

 If you were born in Bolivia, then you can get a National ID Card. You will need to provide your original birth certificate in order to get a National ID Card. (Source: <u>SEGIP</u>)

- 2. If you were not born in Bolivia, then you can apply for a temporary or permanent residence sticker from the General Directorate of Migration.
 - To get the sticker, you will need a foreign identification document, like a Passport or National Identification Document
 - (b) The General Directorate of Migration website has a form to apply for temporary or permanent residence: <u>http://www.migracion.gob.bo/node/130</u>

Once you have the sticker, you can then apply for a Foreigner Identity Card.

What can I do if I do not have residency in this country?

If you are not a Bolivian resident, you cannot get a National ID Card, but you can get a Foreigner Identity Card.

As long as you have foreign documents, you can obtain a Foreigner Identity Card, it is issued by SEGIP. But first, you must get a temporary or permanent residence sticker from the General Directorate of Migration.

Here are the steps to obtain a Foreigner Identity Card:

- 1. Get a temporary or permanent residence sticker from the General Directorate of Migration
 - (a) To get this, you will need a foreign identification document, like a Passport or National Identification Document
 - (b) General Directorate of Migration website has a form to apply for temporary or permanent residence: http://www.migracion.gob.bo/node/130
- 2. Pre-register on the SEGIP website by filling out an online form
 - (a) On SEGIP website, select "Foreigners>Foreigner Identity Card>Pre-Registration", and click on the "PRE-REGISTRATION" link

Will I need a mailing address? What can I do if I am homeless?

You should not need a mailing address in order to get a National ID Card. Requirements for getting a National ID Card are listed below:

For youth under 18 years old, these are the documents that are required in order to get a National ID Card:

- Original birth certificate issued from 2007 onwards (Only for First Time registration in the RUI-SEGIP system)
- Bank deposit slip.
- Physical presence of the minor.
- Physical presence of one or two parents carrying their valid identity cards and a photocopy of them, also in renewal and replacement.

For people 18 years old and older, these are the documents that are required in order to get a National ID Card:

- Updated original birth certificate, (Only for registration for the First Time in the RUI-SEGIP system)
- Bank deposit slip.

What is the application process? Can I complete it online?

The application process for a National ID requires you to visit one of the Servicio General de Identificación Personal (SEGIP) offices in person. There is no online application.

Is there an application fee? Is there a waiver option if I cannot afford to pay it?

Yes, there is a fee to get a National ID card. I do not see specific fee amount information/fee waiver information provided on the SEGIP website.

I believe you would need a power of attorney to represent you, or an adult to represent you who could provide documentary evidence of the family relationship with the youth (parents, children, siblings, spouses and others).

You must be 18 years of age or older to get a National ID card by yourself.

- Traffic background certificate from the FELCC-FELCN
- Proof of bank deposit, according to the category of driver's license

What documents do I have to have to get a driver's license? Is there any document that I must have to get a driver's license?

According to the SEGIP website, you will need:

- A valid identity card (cédula de identidad vigente)
- Original certificate that states you can drive safely issued by the SEGIP-SEGELIC
- A medical exam issued by a health center authorized by the SEGIP-SEGELIC
- A certificate of driving records
- A bank payment/deposit proof depending on the type of license.

What if my documents do not have my correct name/address?

Same documents as number should more or less apply here as well.

What if I only have foreign documents?

There is a separate process for foreign citizens, one of them is to have a "ficha kardex" in order to obtain a "courtesy driver's license".

Where do I get my birth certificate if I was born in another country?

Children under 12 years old and from 12 to 18 (with an administrative procedure), with a Bolivian parent may apply for a Bolivian birth certificate. The Birth Certificate is issued at the moment of the registration. For persons over eighteen years old, the procedure must be done in Bolivia directly.

Is there a way to get my birth certificate without going somewhere in person?

No, obtaining a birth certificate is contingent upon access to a Civil Registry Office. There are many offices scattered throughout Bolivia and their location can easily be found at the SERECI (El Servicio de Registro Civico) website.

Rural access to these locations however remains somewhat limited.
